The Auditor quit in frustration citing his independence had been compromised. • Abused her position by reporting or facilitating the reporting of misleading information to the state police about a councilman with opposing views. • Harassed Public Works Director, Royal Gasso; City Recorder, Mary Goddard and other employees. • Aligned herself with a malicious publication that prints and distributes defamatory articles and false charges of wrong doing against employees and council members with whom she disagrees. • Spearheaded the suspension of Roberts Rules of Order at the January 8th council meeting, further injuring the city's reputation because she didn't want to follow those rules. This demonstrates she is unwilling or unable to work within established guidelines. • Her disregard for rules, laws, contracts and legal advice create a damage to the city from potential lawsuits. <p>Stop the abuse and protect the city. The auditor never named me as one of the council members that did try to influence his audit. • The information I gave to the State police was true. The views of the councilman in question were not the issue his actions were. • I have never harassed any city employee and no reports have ever been filed. • I do not use any publication to attack anyone. • Acting on advice of the City Attorney, the majority of the council supported the suspension of Roberts Rules for a one time action in an attempt to safe guard the City from potential legal action, and to correct a procedural violation by the previous council's "special" meeting of Oct 24, 2006 where both Robert's Rules and State Law were ignored. • These frivolous allegations are an attempt to stifle opposition to the long standing council's business as usual attitude, which is usually just bad business for the city.
