If you make a mistake or damage your ballot, call your County Elections Office to ask for a replacement ballot.</p> <p style="text-align: center;">City of Jacksonville</p> <p>15-105R REASON FOR DEMANDING RECALL OF DONNA SCHATZ, JACKSONVILLE CITY COUNCILOR, AS PROVIDED ON RECALL PETITION:</p> <p>The elected Jacksonville, Oregon official named above has failed to manage public funds [taxes, surcharges, etc.] prudently and with due regard to the city's needs and the reasonable expectation of its citizens for orderly stewardship.</p> <p>JUSTIFICATION STATEMENT AS PROVIDED BY DONNA SCHATZ:</p> <p>The recall activity is focused on the fire department and its funding.</p> <p>The city council put a proposal to the voters in May 2010 based on public input and council's deliberations. When the voters rejected the ballot measure, the council needed to find an interim plan that addressed the existing funding deficit and provided a competent level of emergency services for the community. Everyone needs to recognize that the plan, now in effect, is an interim plan. Any final resolution of service levels, facilities, and costs should be defined by vote of the people.</p> <p>In 2011, I expect the council to take additional public input, and offer one or more ballot measures in May to determine the citizens' expectations of emergency service levels and the costs they are willing to pay.
